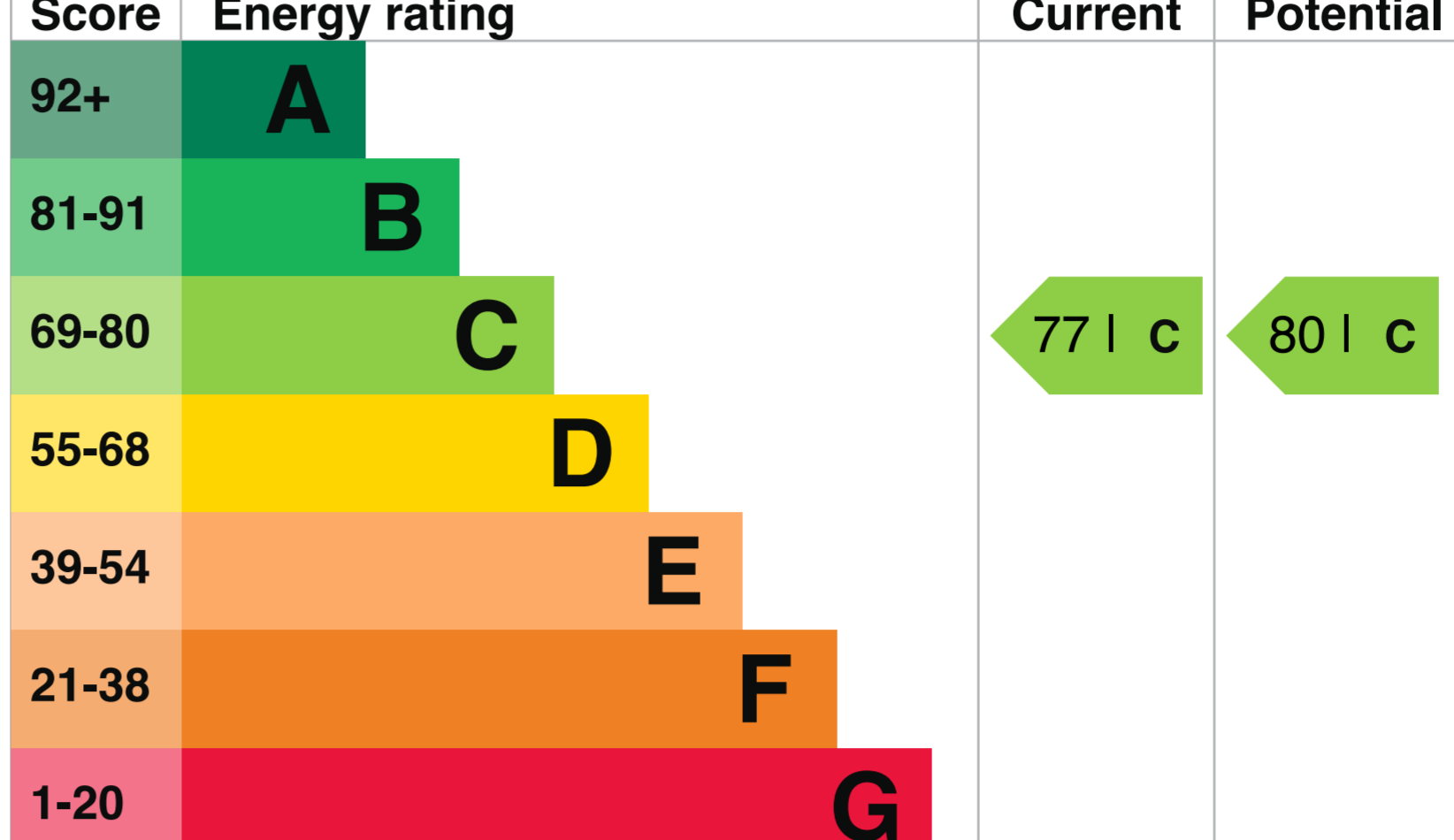

## Environmental impact of this property

This property's current environmental impact rating is D. It has the potential to be D.
